## In Our Courts



## **Litigation Update**

The courts continue to experience a significant trial backlog due to the pandemic. Even when our prosecutors and defense attorneys are ready for trial, cases are routinely being delayed due to limited trial courtroom availability. We will continue to advocate for more courtrooms to be made available for trial. Although we have been able to bring more cases to trial in recent months than during the early months of the pandemic, we are eager to try more cases so we can seek closure and healing for crime survivors, their families, and the accused.

### **Guilty Verdicts in Rape Trial**

Earlier this month, our office secured multiple guilty verdicts at trial in a violent 2014 rape. The jury reached guilty verdicts on seven felonies, including Forcible Rape, Assault with Intent to Commit Rape and False Imprisonment.

Our office worked closely to support the survivor throughout this case, and we commend her for her strength and courage over the many years it took to bring this case to trial. A special thanks to lead prosecutor Assistant District Attorney Courtney Burris for her hard work and dedication.

### **Hate Crimes Charged**

This week our office filed 7 felony charges, including hate crime allegations, for seven separate robberies against Asian women, many of whom were monolingual Cantonese speakers. Those who commit violence or target our AAPI community members will be held accountable. We know the pain that crimes like this can cause to the broader community; these attacks against Asian women occurred during a time when many in the AAPI community across the nation have felt especially vulnerable. We will continue to work to protect the AAPI community and keep everyone safe.

We urge members of the AAPI community, particularly the elderly, who feel unsafe to reach out for support. Seniors in need of escorts for activities like medical appointments or grocery shopping can reach out to Self Help for the Elderly's <u>escort program</u>. 
### **Amicus Briefs**

### **Supporting Overdose Prevention Sites**

This month I signed onto an amicus brief before the United States Supreme Court for the case of *United States v. Safehouse* in support of overdose prevention sites. San Francisco, like much of the U.S., has been devastated by an overdose epidemic that has only worsened during the pandemic. We know that criminalizing substance use <u>does not reduce drug abuse</u> and harms families and communities.

We need new approaches. Overdose prevention sites, also known as safe consumption sites, save lives; to date, no one inside a safe consumption site has died from an overdose. These sites serve also as harm reduction centers where people can access medical care, social services, and treatment.


I am proud to have signed the *amicus* brief along with more than 80 current and former elected prosecutors and law enforcement leaders.



### **Supporting Reproductive Rights**

I signed onto an *amicus* brief before the U.S. Supreme Court to protect the constitutional right to abortion and to prevent the criminalization of women exercising their right to choose. In *Dobbs v. Jackson Women's Health Organization*, the Supreme Court will consider Mississippi's law banning abortion after 15 weeks of pregnancy and the future of *Roe v. Wade* is on the line.


Public safety must mean protecting public health. Overturning *Roe v. Wade* would increase the incidence of vulnerable individuals seeking unsafe and unregulated abortion procedures. We must promote public safety by protecting the rights of all persons to control their bodies and access safe healthcare.



### Supporting a Class Action Lawsuit Against the Bail Bonds Industry


Earlier this month, we joined Prosecutors Alliance of California in filing an *amicus* brief in support of a class action lawsuit against Bad Boys Bail Bond Corporation. The lawsuit alleges predatory lending practices and harassment.

One of my first acts as District Attorney was to eliminate the use of money bail in our office. The bail bond industry profits off charging exorbitant fees to primarily low-income people—disproportionately people of color. We support the application of consumer protection laws to protect vulnerable consumers from misleading, unlawful behavior by the bail bond industry. Thank you to Assistant District Attorney Alex Feigen Fasteau for the excellent work on this issue.

# Centering Survivors: Creating Interventions that Heal, Not Harm



October is Domestic Violence Awareness Month, when we raise awareness, support survivors, and continue to work to stop interpersonal violence. On September 30, the eve of Domestic Violence Awareness Month, our office will hold a convening of survivors, community leaders, researchers, and practitioners focused on how we can better serve survivors and developing effective responses to interpersonal violence. I will moderate two panels, one focused on uplifting

survivors' perspectives and another devoted to intervention strategies. This will be a hybrid event; panelists and attendees can join <u>in person</u> at Manny's in the Mission or via Zoom.

According to <u>CDC data</u>, 1 in 4 women and 1 in 10 men will experience physical violence by an intimate partner at some point during their lifetimes. Our office works every day to hold those who commit acts of violence accountable, including domestic violence. In addition to criminal prosecution, we support interventions that address the root causes of violence and can prevent violence before it happens. We are looking forward to bringing experts and community members together to discuss effective solutions to this widespread problem. ### Partnership to Prevent and Improve Responses to Campus Sexual Assault

We recently announced a new partnership between our office; the San Francisco Police Department, the San Francisco Department of Public Health; and the San Francisco State University Police Department to enhance the reporting and investigation of campus sexual assaults, violent crimes, and hate crimes, and improve support for survivors. Our newly signed Memorandum of Understanding ("MOU") establishes roles, procedures, and practices across these agencies for responding to reports of sexual violence crimes and hate crimes and ensuring that survivors' needs are met. It provides that a victim will receive information and assistance accessing services like counseling, medical examinations, and, when the victim consents, a free sexual assault forensic examination (SAFE) regardless of the victim's engagement with law enforcement.

The MOU establishes ongoing communication and coordination between each agency during pending investigations. The MOU also facilitates access to victim services for survivors of campus sexual assault, when a survivor reports a sexual assault or hate crime on campus, our office's Victim Services Division will be contacted to help link survivors to medical treatment, therapy, victim compensation, and community-based services. This agreement bolsters crime prevention efforts and provides protections for particularly vulnerable groups.

We will continue to develop ways to prevent sexual assault and ensure that survivors are always centered and supported.

In the last month, our office conducted outreach in Districts 1, 7, 9, 10, and 11 as part of our weekly neighborhood walks to talk to merchants and community members about public safety. We will continue to prioritize violent crime and finding ways to prevent homicides and gun violence. Every life lost to violence is a tragedy. We are committed to doing whatever we can together to make San Francisco the safest city it can be.



### **Autumn Moon Festival**

Many countries in Asia— including China, Taiwan, and Vietnam—celebrate Mid-Autumn Festival, also known as Autumn Moon Festival, when farmers traditionally harvest their crops to prepare for winter. We were delighted to join the celebration at San Francisco's Mid-Autumn Festival in the Richmond District, along with Mayor London Breed, Supervisor Connie Chan, and Assemblymember Phil Ting. Festivities included a lion dance, live music, and delicious mooncakes. ### The Clean Slate Expungement Coalition

We are proud to be part of the Clean Slate Expungement Coalition, a joint effort between our office, the San Francisco Public Defender, the San Francisco Police Department, and other community partners to help more than 37,000 eligible San Franciscans expunge non-violent and low-level criminal records and remove barriers to employment, education, and housing. This process plays a critical role in promoting public safety and help build stronger communities. Through extensive outreach efforts, the Coalition has reached thousands of community members and handled more than 1,300 cases in the past year alone.
