

### **Getting started**

Thank you for accepting a referral from the San Francisco District Attorney's Office Victim Services Division. This document is quick sheet with information on becoming a provider or billing as a mental health provider. # To Begin

- You do not have to do anything before you start seeing the client.
- Once you are ready to bill, submit with your first bill:
  - o A completed <u>W9</u>
  - A copy of your licensure
- Once you submit your first bill with the above 2 documents your information will be entered in the Cal VCB provider database

### Billing:

- All bills must be completed on a standard <u>CMS 1500 form</u> using <u>Current Procedure</u> <u>Terminology (CPT) codes</u> used by CalVCB
- The victim's claim number should go in field 1A on CMS 1500 form
- The victim does not need to sign the CMS 1500 form
- Frequently asked questions on completing CMS 1500 are available at <u>FAQ</u> and <u>CMS</u>
  1500 form instructions .
- Please bill after a minimum of 4 dates of service to decrease administrative time

#### Treatment Plan

- CalVCB requires a Cal VCB Treatment Plan form
- Telehealth Forms are required for phone/video appointments
- The completed treatment plan is to be placed in client's file and is to be submitted after the 3<sup>rd</sup> session.
